2010-2011 Tuition and Financial Information

NEW FAMILY APPLICATION FEE: \$75 per family (Non-refundable)

This fee is due before a formal interview will be scheduled and must be turned in with the application.

NEW FAMILY REGISTRATION FEE: \$285 per student (Non-refundable)

The registration is due upon acceptance in order to hold a student's classroom spot.

CURRENT FAMILY RE-ENROLLMENT FEE: \$200 per student before February 1st or \$285 after February 1st (Non-refundable)

STUDENT RESOURCE FEE: (Non-refundable)

\$525 per K3-5th grade student

\$530 per 6th-12th grade student

This fee can be paid up front or added to your payment plan.

TUITION:

Students enrolled on the first calendar day of each month are responsible for that one month's tuition payment, beginning August 1st. One day of school during that month constitutes a full month of tuition and fees. Payment plans include: (1) paid in full, due by August 1st - \$100 discount, (2) paid by semester, due by August 1st and January 1st, (3) paid quarterly, due by August 1st, October 1st, January 1st, March 1st, (4) 10 month payments begin August 1st, or (5) 12 month payments begin June 1st. For those who choose to make monthly payments, those payments **MUST** be made to FACTS, a contractor to Friendship Christian School for collecting and processing tuition and fees. You may pay the student resource fee in advance or you must include it into your payment plan.

AFTER SCHOOL CARE: \$160 per month per student

Aftercare from 2:45pm - 6:00pm is available. There is a drop-in rate of \$3.50 per hour or \$45 per week. An additional charge of \$1.00 per minute is imposed after 6:00pm.

FOCUSED LEARNING CENTER:

The fees below are added to the tuition plan. A separate agreement is signed for this program.

One resource classes:	\$1,500/year
Two resource classes:	\$2,250/year
Three resource classes:	\$2,625/year
Four resource classes:	\$3,000/year
Curriculum Assistance:	\$600/year
Remedial Reading class:	\$1,500/year

EARLY WITHDRAWAL FEE:

A withdrawal fee will apply for any student who withdraws after August 1st. For students withdrawing between August 1st and the end of the first semester, a fee of 50% of the remaining unearned tuition balance is due. A withdrawal fee of 100% of the remaining unearned tuition will be due for students who withdraw between the day after the end of first semester and the last day of school.

LATE FEES AND RETURNED CHECKS:

A late fee of \$20 is added to the student account if not paid within five days of the due date. A returned check results in a \$30 returned check fee to cover bank charges. If you have insufficient funds for a FACTS withdrawal, your account will be charged an additional \$25 by FACTS.

FINANCIAL AID POLICY:

Friendship Christian School believes that Christian education should be available to all families regardless of social or economic status. The purpose of the FCS Financial Aid Program is to assist families of current students who demonstrate a need for tuition assistance. More information can be obtained from the school office.

GENERAL FINANCIAL POLICIES:

1. A student will not be enrolled in FCS if there is a previous financial obligation to another school. Before any student will be admitted to the school, all previous tuition, fees, financial obligations, etc. must be liquidated.
2. Any account that is outstanding 60 days after due date may cause the student to be suspended until payment is brought up to date.
3. At the end of a semester, if there are any financial obligations, fees, late charges, unreturned books, unreturned uniforms, etc., the child will not be allowed to take his/her final examinations, participate in Kindergarten or High School graduation, or any other activity involving FCS. We will not report a grade for that semester or release student records for that student.
