### OPTIONAL PROGRAM COSTS:

#### FOCUS LEARNING CENTER:

FCS is unique in that we accept students who have intellectual disabilities, Autism, Down syndrome, etc... Students will receive core class instruction in small resource classes targeted to their specific learning needs. Students will participate in elective classes as well as inclusion opportunities throughout the day. When these students enter sixth grade, they may enter the Focus Learning Center which concentrates on general academics and life skills. Careful planning and review of the students' past academic performance and current cognitive and achievement levels will assist in making this decision. These students would be eligible to receive a diploma in an Occupational Course of Study.

**FLC Tuition** (full time student) \$10,830

#### SPECIALIZED LEARNING CENTER:

Students who have learning disabilities generally have IQ scores that fall in the average to above average range. The types of learning disabilities that we have addressed are dyslexia, language impairments, and difficulties with reading mechanics and comprehension, math reasoning and calculation, written expression, oral expression, and central auditory processing. Other challenges include attention deficit hyperactivity disorders (AD/HD), high functioning autism, and Asperger's syndrome. For an additional fee, we offer small group resource classes for students who need additional help to catch up to grade level or who would benefit from a small group environment with a teacher who specializes in students with learning disabilities. Tutorial Study Hall is also available if the student can keep up in the regular classroom but needs the daily assistance offered there. A child must be accepted into this program. Please refer to the website for more information about the program and possible tax credit breaks.

**FINANCIAL POLICIES:**

**EARLY WITHDRAWAL FEE:**

**A \$750.00 withdrawal fee will apply for any student (Preschool – 12<sup>th</sup>) who withdraws between the time of enrollment/reenrollment and June 30<sup>th</sup>. For students withdrawing between July 1<sup>st</sup> and the end of the first semester, a fee of 50% of the remaining unearned tuition balance for the year is due.**

**For students withdrawing between the first day of the second semester and the end of the school year, a withdrawal fee of 100% of the remaining unearned tuition balance for the year is due.**

**All remaining unearned Student Resource and Technology Fees balance will also be owed after July 1<sup>st</sup>.**

**FACTS TUITION:**

**Friendship Christian School uses the FACTS tuition program.** FACTS is a tuition collection agency that works through an automated withdrawal system. For more information go to [www.factsmgt.com](http://www.factsmgt.com)

**LATE FEES AND RETURNED CHECKS:**

A late fee of \$20 is added to the student account if not paid within five days of the due date. A returned check results in a \$30 returned check fee to cover bank charges. If you have insufficient funds for a FACTS withdrawal, your account will be charged an additional \$30 by FACTS.

**TUITION ASSISTANCE POLICY:**

Friendship Christian School believes that Christian education should be available to all families regardless of social or economic status. The purpose of the FCS Tuition Assistance Program is to assist families who demonstrate a need for tuition assistance. More information can be obtained from the school office. Current families need to apply no later than May 1<sup>st</sup> to receive assistance for the following year.

**GENERAL FINANCIAL POLICIES:**

1. A student will not be enrolled in FCS if there is a previous financial obligation to another school. Before any student will be admitted to the school, all previous tuition, fees, financial obligations, etc. must be liquidated.
2. Any account that is outstanding 60 days after due date may cause the student to be suspended until payment is brought up to date.
3. The majority of the student textbooks are rentals for the year. Students will be charged for damaged books. It is advised to cover books according to the teacher's policies.
4. At the end of a semester, if there are any financial obligations, fees, late charges, unreturned books, unreturned laptops and chargers, unreturned uniforms, etc., the child will not be allowed to take his/her final examinations, participate in Kindergarten or High School graduation, or any other activity involving FCS. We will not report a grade for that semester or release student records for that student.
5. The duties and obligations under this Educational Agreement may be suspended indefinitely without notice during all periods in which FCS is closed due to any force majeure events, including, but not limited to, any earthquake, fire, flooding, act of God, war, governmental action, act of terrorism, epidemic, pandemic, state of emergency, or any other event beyond its control.
